Franklin County Animal Rescue (FCAR) is the only shelter in almost 900 square miles of northwestern Vermont. A shelters live release rate is the recognized gold standard of a shelters lifesaving work. The outcomes achieved for dogs and cats at Franklin County Animal Rescue exceed Vermont and national averages for six straight years. Franklin County Animal Rescues performance since 2017 ranges from 95% to 98% live release, based on data from the national Shelter Animals Count database and Best Friends Animal Society. Thats far above the 90% save rate considered no kill. Community support is strong as demonstrated by more than 64 active volunteers; more than 1,000 annual donors and among the Top 10 Facebook communities in Franklin County. Franklin County Animal Rescue also was selected as a beneficiary of community fundraising including the Running of the Bells, Haddad Subaru, and others. Franklin County Animal Rescue has ended the past five years in the black and has reserves equal to a year of operational costs.
